How to use it

What is ForeignId?

Is an external identifier that some customers use to identify his members and it is not managed by liquid barcodes.

LB does not provide it, it is external to us. Normally is the final user(member) who select it but also the customer could provide foreign Ids to his members.

Member registration process

Make **POST /user** request - Send ForeignId (any value you want) as UserId (no msn is needed).

POST /initialize and POST /pin requests should not be used in Foreign Id Mode.

Regestered member has obtained LB internal UserID -CWFIDFEA2B75AA9BB248188C9A6B34B1CDFC06 and ForeignId is in ExternalIdentifiers field

Pay attention: For the rest of requests in postman use ForeignId in UserID field . E.g. GET/content.

If you use LB internal UserID , error "user not found" will be shown.
